AUXILIARY HISTORY



The AUXILIARY, a non-profit organization was founded in 1974 by a group of spouses who recognized the need to form a national auxiliary to support EANGUS. The AUXILIARY is a grassroots organization that began with 11-chartered state auxiliaries. Through growth and prosperity, it now has 50-chartered states. The purpose of the AUXILIARY is to support THE ENLISTED ASSOCIATION OF THE NATIONAL GUARD OF THE UNITED STATES (EANGUS), in attaining goals and objectives, and to provide support and fellowship among National Guard families. Along with supporting the ENLISTED ASSOCIATION'S legislative efforts, the AUXILIARY is also concerned with family issues and provides scholarships for spouses and dependents.

The AUXILIARY supports and promotes EANGUS. Among the many support efforts, the AUXILIARY provides support of legislative efforts for the improvement and retention of benefits for members of the National Guard and their families, and assists with planning and preparations of the EANGUS and AUXILIARY Annual Conference.

WHO CAN JOIN THE AUXILARY

Annual Member: A Spouse of active, retired, or former Guard member, who is a member of EANGUS and a member of a state Auxiliary chartered to the National AUXILIARY.

Life Member: A current annual member may apply for life membership by paying a onetime dues payment that is determined by current state and national dues that apply up to age 60. The applicant's spouse must be a Life member of their state association and EANGUS.

National Associate Member: An Individual who supports the objectives of the AUXILIARY but does not otherwise qualify for Annual or Lifetime membership.

National Life Associate Member: An Individual who supports the objectives of the AUXILIARY but does not otherwise qualify for Annual or Lifetime membership by paying a one-time payment of \$100.

Did you know that EANGUS offers a few financial opportunities to help our Guard Families ?

S.A.R.G.E. Grant

WCFA offers an opportunity to a current or former National Guard member in good standing who has experienced a catastrophic or financial hardship and/or personal property loss to apply for a Soldier & Airman Relief Grant for Emergencies (hereafter referred to as "SARGE").

Individuals who are an EANGUS dues paying member (Life or Annual) will be eligible for additional funds. Grants may be used for financial hardships related to events such as mobilization, natural disasters, fires, and other catastrophic losses. The grants are intended for otherwise non -reimbursable expenses (i.e., not covered by insurance) due to these events and include medical bills, utility bills, rent or mortgage payments, groceries, relocation, shelter due to loss of residence and funeral expenses. Other expenses, not listed here, may be deemed appropriate and approved by the committee.

Grants are typically \$500 and are transmitted electronically to the individual usually within 10 days after receipt of completed application.



<u>TEAM EFFORT</u>

With thousands of National Guard members and their families facing financial hardships as a result of the ongoing COVID-19 pandemic, the United Services Automobile Association (USAA), the Enlisted Association of the National Guard of the United States (EANGUS) We Care for America Foundation and the American Red Cross are teaming up to help National Guard members and families in need.

Have you been hit by an unexpected expense?

The EANGUS We Care for America Foundation may be able to help with a zero interest loan. Loans are available in amounts from \$500 to \$2,000. Repayment terms based on loan amount.

Eligibility

- Currently Serving members of the National Guard
- Retired members of the National Guard (includes grey area retirees)
- Prior members of the National Guard who received an honorable discharge

Surviving spouses who have not remarried of Soldiers who died while serving in the National Guard or died after reaching retirement eli-
